Ensemble, les organisations, coalitions et personnes soussignées soutiennent avec force la conclusion du Procureur selon laquelle il existe une base raisonnable pour croire que des crimes de guerre et des crimes contre l'humanité ont été et sont commis dans le Territoire Palestinien occupé, que la Cour pénale internationale peut exercer sa compétence sur l'ensemble du territoire de l'État de Palestine, et soutiennent pleinement, sans plus attendre, l'ouverture par la Cour pénale internationale d'une enquête complète et approfondie sur les crimes internationaux commis en Cisjordanie, y compris à

Jérusalem-Est, et dans la bande de Gaza. Pour le peuple palestinien, la Cour pénale internationale est véritablement une « cour de dernier recours ». Il est temps que justice soit faite. Il est temps d'ouvrir une enquête.
